- \_\_\_ BRAKE FLUID - Hi-temp DOT 4, less than six months old, reservoir full
- \_\_\_ BRAKE PEDAL - Firm, releases freely
- \_\_\_ BRAKE PADS - 1/4" thickness or greater and 3/8" or more for 2 days. (New pads are around 1/2")
- \_\_\_ BRAKE HOSES & LINES - Dry and in good condition, no cracks or bulges
- \_\_\_ BRAKE LIGHTS - Function properly
- \_\_\_ TIRES - Good condition, no cracks or bulges, no more than 5 years old (date code on sidewall), properly inflated
- \_\_\_ THROTTLE RETURN - Returns freely, good springs, no binding
- \_\_\_ SUSPENSION & WHEEL BEARINGS - Tight with no free play
- \_\_\_ WHEELS - No cracks, bends. All lug nuts properly torqued
- \_\_\_ WINDSHIELD - No cracks
- \_\_\_ MIRRORS - At least one securely mounted rearview mirror
- \_\_\_ SEAT BELTS - Factory belts in good condition or approved replacements mounted metal to metal, incl passenger seat
- \_\_\_ BATTERY - Securely fastened, good condition, no acid leaks or corrosion
- \_\_\_ FIRE EXTINGUISHER - Recommended, but not required. If installed, must be securely anchored to car structure
- \_\_\_ HELMET - Snell **SA2020** or newer, certification sticker attached. NO motorcycle helmets. (Rentals available \$25/day)
- \_\_\_ LOOSE OBJECTS - Removed from all compartments, trunk, and driver side floor mat removed
- \_\_\_ **APPAREL** FOR FIRE PROTECTION - Full length cotton pants, long sleeve cotton shirt, cotton socks & closed-toe shoes
